

Privacy Policy

This Privacy Policy outlines the types of personal information SAFS, Inc. (“we”) may receive or collect when you use access our site, as well as some of the methods we use to safeguard your personal information.

1. Collection of personal information

Like most companies, we use cookies on our websites. A “cookie” is a small file containing a string of characters that uniquely identifies your browser. While most browsers accept cookies by default, you can manually set your browser to refuse all cookies, accept cookies from specific websites, or highlight when a cookie is sent to your browser. Our servers may also automatically record information when you visit our website, including the URL that directed you to our website, your IP address, browser type and the date and time of your visit. While you can generally refuse the use of cookies as described above, some serve an essential function and the websites cannot work properly without them. Where such essential cookies are used, they cannot be disabled.

We use cookies to collect certain aggregate and non-personal information through a variety of technologies when you visit our site. Aggregate and non-personal information does not relate to a single identifiable visitor. It tells us such things as how many users visited our site and the pages accessed. By collecting this information, we learn how to best tailor our site to our visitors. Unless you disable such technologies, by using our site, you agree that we can place these types of cookies and related technologies on your device.

We may also collect personal information with your consent for a variety of reasons. Personal information is information about you that is personally identifiable, such as your name, address, email address, or phone number.

2. Policy on sharing your information

We will not sell, rent or lease your personal information to others. We may share personal information with companies working on our behalf, including our affiliates and subsidiaries. In any such cases, however, we require that the companies or entities adhere to privacy standards and policies at least as restrictive as those that we have in place. In the event that we undergo a change in ownership at any point (or otherwise change our business structure), it is our established practice to seek appropriate protection for all personal information in advance of any such change.

We may have an obligation to disclose information to the extent such disclosure is reasonably necessary to: (a) satisfy any applicable law, regulation, legal process or legitimate governmental request, (b) detect, prevent, or otherwise address suspected fraud, security or technical issues, (c) enforce any applicable terms of service, including investigation of potential violations thereof, or (d) protect against imminent harm to our rights, property or safety, or to our users or the general public as required or permitted by law.

Our website may from time to time link to third party websites for your convenience and to provide easy access to additional useful information. Should you select such a link, you will leave our website. We do not control those sites or their privacy practices, which may differ from our practices and policies.
